This practice gives Helen Goldstein an incentive to recommend insurance products based on the compensation received, rather than on the client's needs. Clients are not obligated to act on any insurance recommendations or place any transactions through Helen Goldstein or BPIS if they decide to follow Ms. Goldstein's recommendations.

In addition to her role with Beacon Pointe Advisors, LLC, Helen Goldstein spends a portion of her time as a registered representative of Purshe Kaplan Sterling Investments, a non-affiliated registered broker-dealer. In this capacity, Helen Goldstein may make security recommendations, offer investment products and/or effect securities transactions. When effecting transactions, she is eligible to receive compensation, commissions and/or trailing 12b-1 fees from Purshe Kaplan Sterling Investments, Inc. for products held by BPA's advisory clients.
